### Clinical leads update



- A range of Clinical Lead roles are agreed annually to support the delivery of the CCG's priorities for the year. A recruitment and selection process was undertaken in March as part of the transition to the new single NCL CCG.
- The majority of the roles for 2020/21 were recruited to at this time, however a number remained vacant. We have now completed the second round of recruitment and confirm we have finalised appointments for almost all of the vacancies.
- We are delighted to welcome a number of new clinical leaders who are joining the CCG as a result. We will continue to explore options for filling the remaining vacant roles.

- At the end of July, NHS England and Improvement shared a letter from Sir Simon Stevens and Amanda Pritchard, outlining the next phase of recovery and response to Covid-19.
- The letter sets out priorities for the next phase of recovery. These are:
  - Accelerating the return to near-normal levels of non-Covid health services, making full use of the capacity available in the 'window of opportunity' between now and winter.
  - Preparation for winter demand pressures, alongside continuing vigilance in light of further probable Covid spikes locally and possibly nationally.
  - Doing the above in a way that takes account of lessons learned during the first Covid peak; locks in beneficial changes; and explicitly tackles fundamental challenges including: support for our staff, and action on inequalities and prevention.



- NCL is expected to develop a response as a system covering the key actions set out in the letter, with a draft summary plan expected by 1 September, and a more detailed final plan using the templates provided by 21 September.
- Where possible, these plans will build on existing recovery plans and in most cases will require a refresh of the activity and performance submissions for our Operating Plan made prior to the Covid-19 pandemic response.
- The following principles will guide our system response:
  - Everything we do through this process has a positive benefit for our system / residents / patients as well as meeting requirements for NHSE/I.
  - ✓ We put the resident / patient view at the forefront all our plans.
  - ✓ Where possible, we draw on / point to existing work and only carry out additional work where this is required.



- NCL Gold agreed that there would be a single coordinated approach to developing an NCL System Plan for Phase 3, led by Will Huxter, Executive Director of Strategy.
- To support a system response, there will be an overarching NCL action plan with system leads assigned to each area.
- Work is underway to meet the below timeline and with many CCG staff supporting the response.

- In response to the COVID-19 pandemic, temporary changes were made to children and young people's services across north central London (NCL) to ensure that patients received the very best care.
- To make sure we can continue to provide the best care possible throughout the winter and are prepared for a potential second surge in COVID-19 cases, a review of children and young people's services across NCL has been taking place.
- The review concluded that staffing levels are a challenge to being able to maintain safe and resilient services for children and young people and has recommended bringing together a smaller number of emergency departments and inpatient units.
- Temporary changes (to April 2021) will be implemented following the review.



In the coming weeks the following temporary changes will be made to children and young people's services across NCL:

- Barnet Hospital emergency department and inpatient unit will reopen on Monday 24
  August, including child and adolescent mental health services crisis support.
- Royal Free Hospital emergency department and inpatient unit will be closed.
- Whittington Health emergency department and inpatient unit will be expanded.
- Great Ormond Street Hospital will provide an enhanced role for elective inpatient services and some – but not all – day surgery, building on existing arrangements.
- The emergency department and inpatient unit at North Middlesex University Hospital will remain open.
- University College London Hospitals will continue to provide specialist inpatient and day case services, including cancer haemato-oncology and complex adolescents.

 The UCLH children and young people's emergency department will remain closed over winter.



- The proposals have been agreed by the senior and clinical leadership of NCL and NHS England and Improvement London.
- A group of senior operational and clinical leads from across NCL are working together on implementation plans.
- We are in the process of talking to all staff affected and continuing to work on some pathways which remain unresolved.
- These changes are likely to be implemented in the next month and we will of course keep you updated.
- Other stakeholders including patients, the public and key partners will be also informed as the implementation schedule is finalised.
- These changes are temporary and will be in place until April 2021 and evaluated throughout this period.







- As part of continuing our development of the ICS for NCL, an ICS leadership team is being established. The remit of the team is to:
  - ✓ Continue to ensure that Major Incident Gold ICS decision-making processes are in place to ensure the operational incident response to Covid-19 level 3 major incident is running effectively.
  - ✓ Make the decisions required to be made at ICS level to re set health and care services in line with planning guidance 'The Journey to a New NHS'.
  - ✓ Oversee the refresh of the STP Long Term Plan response and the system financial plan, and the co-production of refreshing the ICS vision and strategy.
  - ✓ Approve the establishment and objectives of ICS projects and programmes.

✓ Oversee and assure the delivery of programme objectives.



- The membership of the leadership team will evolve in response to circumstances, with formal review every six months.
- A number of members of the leadership team are well known to staff:
  - Rob Hurd, ICS lead
  - Frances O'Callaghan, NCL CCG Accountable Officer
  - Dr Jo Sauvage, NCL CCG Chair and medical lead
  - Will Huxter, Executive Director of Strategy.
- The leadership team will align with other elements of ICS design that are ongoing, including developing Strategic Commissioning, the potential provider alliance, and local borough-based Integrated Care Partnerships.
- We are keen to promote diversity on the team, and to have members who are drawn from a range of organisations.
